Trip Dates: April 10 – April 13 (Sunday-Wednesday)

Travel Requirements during COVID Pandemic

1. All students must purchase Travel Insurance from Travel Insured International PRIOR to making the first senior year payment. Travel Insurance is \$81.00 and must be purchased by copying and pasting this link:

  - a. If the LRHSD cancels the senior trip for the safety of our students and staff (i.e. Travel Restrictions/Recommendations) you will be refunded 75% of the cost of the trip (excludes Class t-shirt and trip bag) paid through Travel Insured International.
  - b. All refunds will be processed by Travel Insured International. Neither Cherokee nor the LRHSD are responsible for issuing this refund.
2. Proof of purchased travel insurance must be with you when you make your first senior year payment.
3. All students MUST have a NEGATIVE COVID TEST result within 5 days of departure OR proof of full COVID 19 vaccination.
4. If a student tests positive for COVID while on the trip, a parent/guardian MUST travel to Orlando in order to transport the student home. This cost will be incurred by the parent/guardian.

Cancellation Policy

1. All cancellation requests must be submitted in writing to class advisors.
2. Any cancellation after December 3, 2021, will be subject to a \$450.00 penalty. The remaining balance of your trip will be refunded. Travel Insured can be contacted to make a claim for the \$450.00 cancellation penalty.
3. Any cancellation after January 7, 2021, will result in a 100% cancellation penalty. Travel insured can be contacted to make a claim for the cost of the trip.

Room Assignments

1. Students are **strongly** encouraged to sign up for room assignments in pairs or quads, room rate will vary based on double or quad occupancy. Students who sign up individually will be subject to another student(s) being placed in their room.
2. Rooms that have a student or students added from the wait list will be assigned to a room based solely upon availability. Affirmative action law (Title IX of the Education Amendments of 1972) prohibits discrimination based upon a student’s race, color, national origin, ethnicity, disability, sexual orientation or religion. Cherokee High School and the Lenape Regional High School District have sole responsibility in determining a student’s “eligible” status and/or room assignment.
