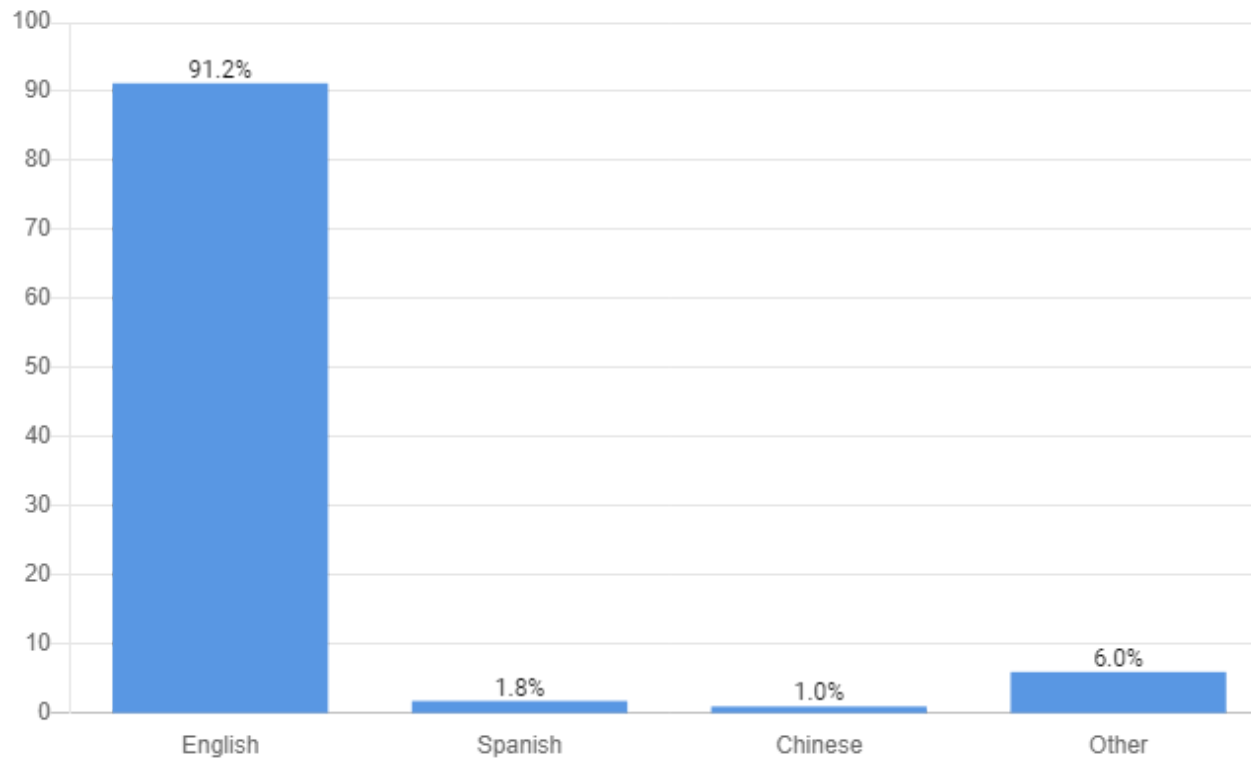

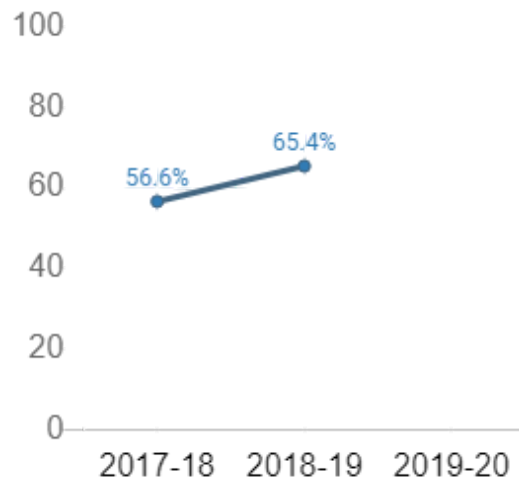

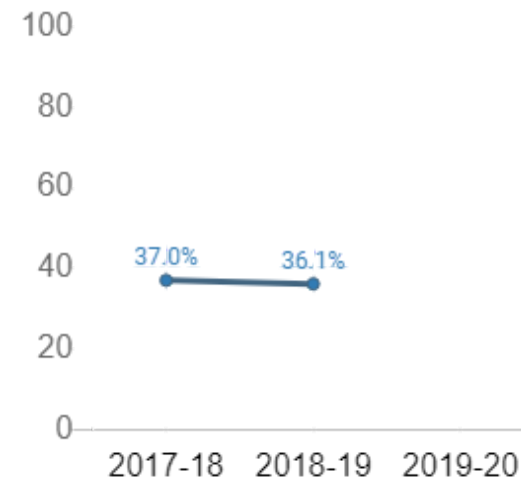

NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. 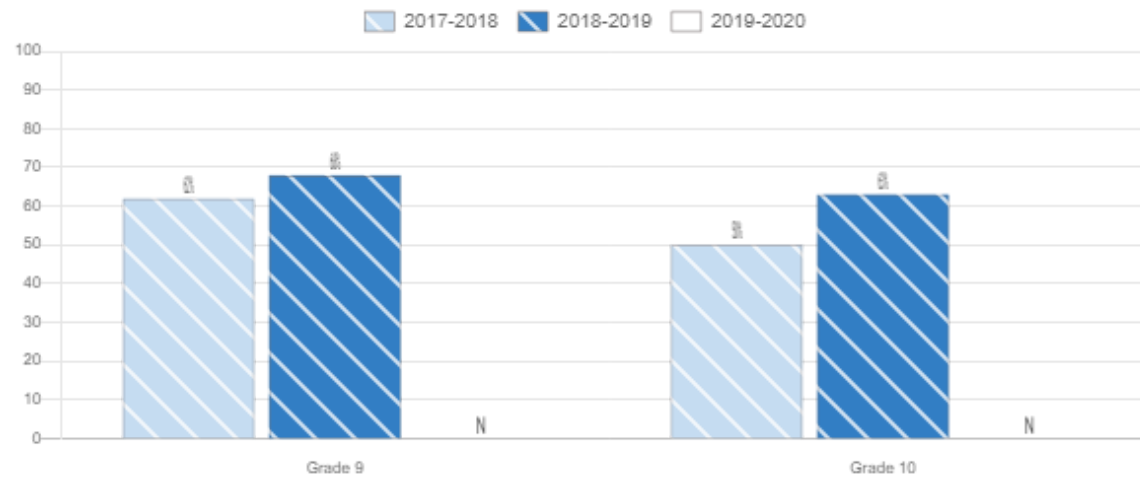

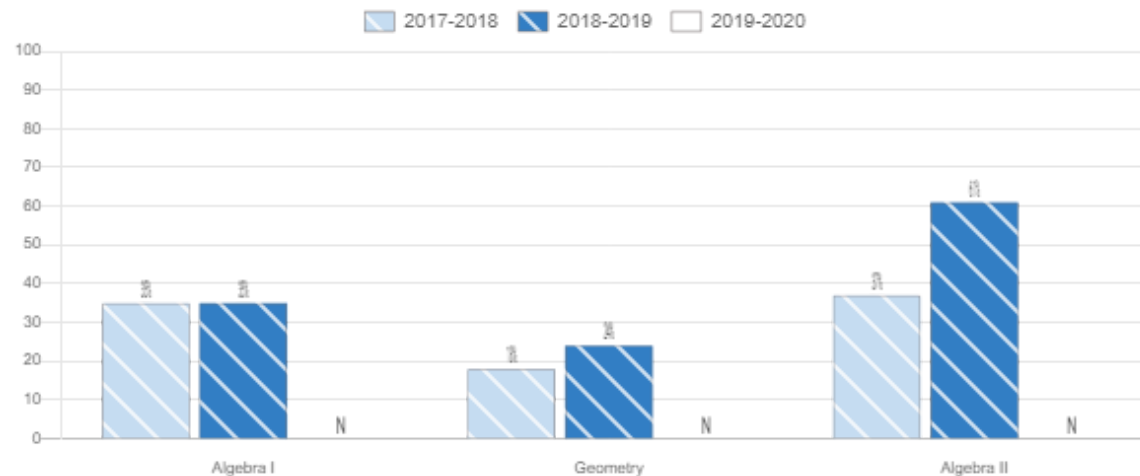
Mathematics Assessment – Performance Trends

DLM Alternate Assessment - Participation

English Language Progress to Proficiency

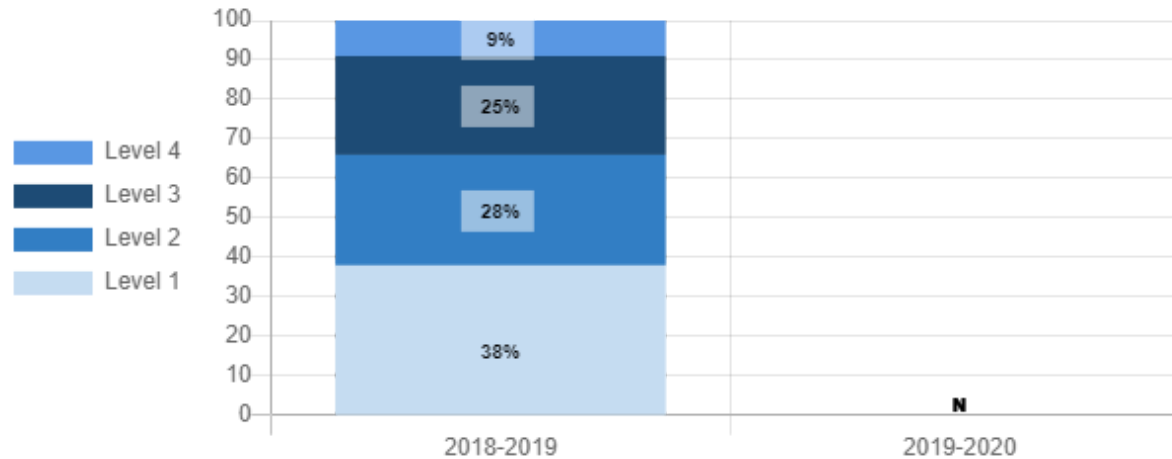

All students in grades 5, 8, and 11 will take the NJSLA-Science assessment. Students receive a score of Level 1, 2, 3, or 4 where levels 3 and 4 represent proficiency. 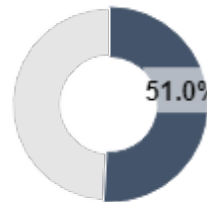
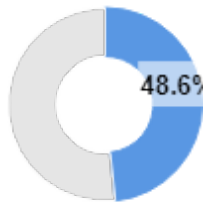

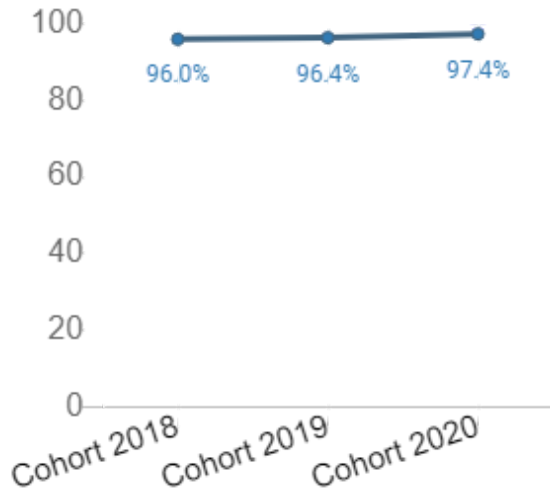

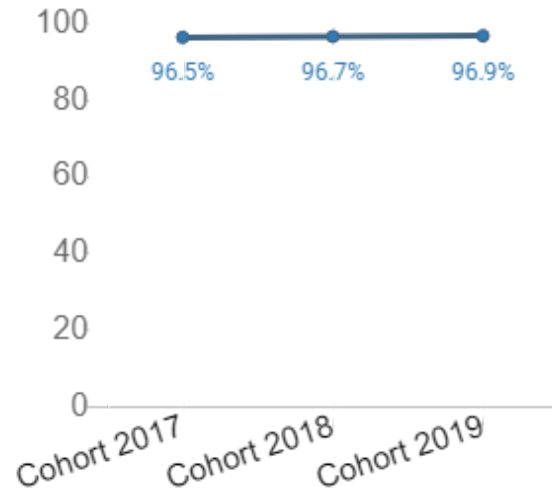

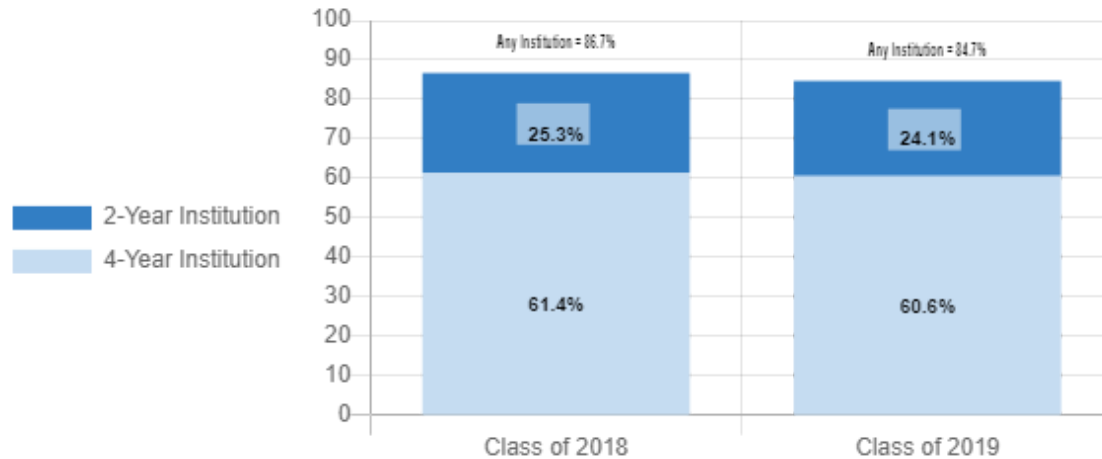

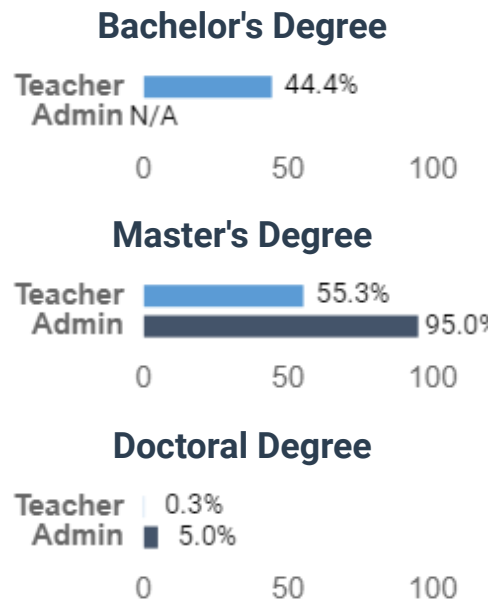

This removes the requirement to:

Due to the COVID-19 pandemic and associated federal waivers, New Jersey has submitted a proposed addendum to New Jersey's consolidated state plan to delay the next identification until the 2022-2023 school year (based on 2021-2022 data) and also delay the exit of all currently identified schools to align with the next identification.

For the annual identification of schools for Targeted Support and Improvement: Consistently Underperforming Student Group, no schools will be identified during the 2020-2021 school year as a result of the March 2020 waiver. New Jersey has submitted a request to USED to waive the next identification in the 2021-2022 school year due to the lack of two consecutive years of data.

Because these requests to adjust exit dates are dependent on approval by USED, exit dates are not included in the 2019-2020 reports. Updated exit dates will be shared directly with districts when they are finalized. Check the [accountability resources](#) page for current information.

All schools utilize email, Genesis Gradebook, a mobile app, Twitter, Facebook and Instagram to connect with families. Facilities:

Lenape High School opened in 1958 on a 53-acre plot of land in Medford, NJ. Situated on a parcel of land in the southeastern end of Medford Township, in the heart of the Pinelands, Shawnee High School was dedicated in 1971. Cherokee High School was opened on a 71-acre site in Evesham Township in September 1975. The Seneca High School building is 17 years old and located in the Pine Barrens National Preserve. The District also has the Sequoia Alternative Program and Transitions to Adulthood Program, both are located in Evesham Township.



School Safety:

The Safety and Security of all LRHSD students and staff is a top priority which is evidenced by the following security initiatives already in place at all LRHSD schools. Police officers with marked vehicles are assigned to each school reinforcing high visibility police presence. All LRHSD schools have Security Staff (several retired Law Enforcement Officers) assigned to assist with maintaining a safe school environment. All exterior doors are secured and locked during the school day. Main office vestibules were constructed to limit direct entry into the school. All schools are equipped with 24/7 interior and exterior surveillance systems. Lockdown buttons and a new phone system were installed at all schools to initiate and expedite lockdown procedures. Portable radios are assigned to key personnel to expedite communications in the event of an emergency. New classroom and office locks were installed to expedite the lockdown process and intruder film was added to all exterior doors.

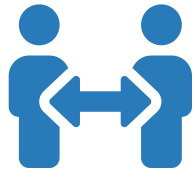

Technology and STEM:

The LRHSD has a variety of technology and STEM opportunities for students. A wide-range of technology courses offered include a 3 year Television Broadcasting path with a 4th year option to intern in the District Television Studio. Technical courses expose students to industry-standard software. Also offered is an Automotive shop at Seneca and Cherokee and a Metal Shop at Lenape High School. The LRHSD has also partnered with Project Lead the Way a nationally recognized STEM program to offer a pre-engineering pathway where students work collaboratively in a cohort to take an engineering elective each year of their high school experience. This will expose them to different facets of a STEM related career. The LRHSD has two district Robotics teams which compete locally and nationally. Members of the LRHSD Robotics teams report that the project based problem solving design of each challenge deepens their understanding of the concepts behind the designs necessary to compete.



Learning During COVID-19:

When the COVID-19 pandemic threatened to move the 2020 graduation ceremonies online, the LRHSD proposed "Diploma to Door" ceremonies on the district's original graduation date of June 16, as well as socially distant ceremonies later in the summer in mid-July in hopes that the state would raise its limit for outdoor gatherings. In the end, the New Jersey Governor did raise the limit to 500 people, and the district happily went through with both events. Through "Diploma to Door," school administrators personally delivered students' diplomas to their homes, where family and friends looked on safely from a distance. The district presented 1,058 diplomas through this carefully coordinated event. To adhere to the 500-person limit in July, the district planned a total of 12 in-person graduation ceremonies over two days at four different high schools to ensure that each graduate could invite two guests. LRHSD celebrated 1,321 total students through the in-person ceremonies.

LRHSD has a wonderful partnership with local law enforcement agencies. LRHSD has a School Resource Officer (SRO) assigned to each school. All of the SROs play a vital role in the daily safety and security of all students, staff and visitors at each school. LRHSD has a 4-Day Rotating Schedule. Measurable outcomes include increased instructional time, improved average daily attendance, an increase in average daily punctuality and a decrease of discipline incidents and suspensions. The District's high expectations for its students is one of the ingredients to its success. During the 2019-20 school year each high school celebrated students' college acceptances in a variety of ways as a strategy for raising expectations.
